Regular members are local cooperatives, credit unions and other associations and cooperatives operating upon a cooperative plan, and regional or state federations, associations or council of the same. The maximum dues paid per cooperative per year shall not exceed \$465.00. **Note: new cooperatives developed by Montana Cooperative Development Center pay only \$50.00 per year for their first 3 years as regular Council members.**

Associate members shall have the right to attend all meetings and participate in all discussions but shall have no right to vote in meetings of the Council.
